Outline of the Organization of FINMAC

Financial Instruments Mediation Assistance Center (abbreviation: FINMAC) is an organization that accepts consultations and complaints regarding troubles related to transactions of financial instruments, including stocks, investment trusts, and foreign exchange margin trading (FX), and resolves disputes in a fair and neutral manner.

In the event users are not satisfied with the handling of consultation and complaint, FINMAC provides for the settlement of disputes through mediation by lawyers.

(Note) FINMAC is an abbreviation of the capital letters of Financial Instruments Mediation Assistance Center.


